There is perhaps no period of British foreign policy that more readily whets the appetite than the Second World War. For those unable to make use of the Public Record Office in Kew, there is also no modern period more poorly covered in terms of published documentation. The origins of the war — and the British role during the period from 1919 to 1939 - can be examined in considerable detail in the fifty-nine volumes of the four series of Documents on British Foreign Policy 1919-1939 published by HMSO between the late 1940s and the 1980s. However, a combination of security and financial considerations prevented the publication of an equivalent series of volumes for the Second World War. Instead, there were commissioned a large number of volumes of an official history of the war, with series devoted to many aspects of the war effort — grand strategy, intelligence, foreign policy, economic policy and so on. The historians invited to write these volumes had unlimited access to the relevant official documentation, as a result of which, in a few cases, their publication was delayed for many years. Nevertheless, despite individual variations, the volumes of the official history are of uniformly high quality. Moreover, through both their quotations from official documents and their footnotes to others, they provide an introduction to the extant documentation but, for many historians, a far from satisfactory substitute for it.

It is precisely for this reason that the third and later parts of the BRITISH DOCUMENTS ON FOREIGN AFFAIRS assume a greater importance even than that of their predecessors. Unlike the earlier parts which represented a selection of the Foreign Office Confidential Print, Part 3, 4 and 5 publish the confidential prints in their entirety. Parts 1 and 2 were invaluable and, for many historians unable to visit the Public Record Office, provided an essential supplement to the published documents. Given the vacuum which they now fill, Parts 3, 4 & 5 will play a more

crucial role. Given that there is little or no possibility of the British Government undertaking the publication of a Documents on British Foreign Policy 1940-1945, these volumes constitute the nearest equivalent. For that reason they will be an obligatory, inevitable, unavoidable acquisition for every serious University research library in Britain, the United States, Europe and the bulk of the English-speaking world.
